Vendor Rules:

Booth size is 15X15. Vendors will receive two (2) event passes with their vending space. Passes will be held at the gate for pickup on arrival. If more than two (2) persons will be working, or attending the Field Meet with you, they will be required to purchase a ticket. Tickets will be available to vendors at the ABATE member discount. Camping fees are included in your vending fee.

If electrical hook-ups are required, this is \$15.00 additional (included with food vendors fees). Please specify the voltage and amperage required on the application form. These spaces are limited and will be on a first come, first serve basis. If you plan to stay after dark, you will need electricity for lights. Coleman lanterns are permitted, but we take no responsibility for injury, damage or loss.

You are responsible for your booth, tables, chairs, tent, etc.

Booths will be assigned on a first come, first serve basis. Vendors may set up anytime after 6:00pm on Thursday night.

Items that are considered weapons will not be allowed for sale. This includes firearms, fireworks, swords, etc. Items imprinted with the name of the event are not allowed as ABATE sells event products themselves.

Arts & Crafts booths that choose to sell food items will be required to register as a food vendor and pay the appropriate fees.

Music may not be played at the booths as this conflicts with the scheduled events and entertainment.

Vendors must sell out of booth only.

Parking is limited in the park. You can drive to your booth to unload and then park behind your booth.
